County Cllr White had nothing to report.

Borough Councillor report

Borough Councillor Mrs Mellish advised she had made enquiries as to the Information Boards located around the town. Unfortunately initial enquiries indicated there was no funding available for their replacement and the actual artwork was missing possibly due to a change of officers/staff since their inception. She would cause further enquiries to be made.

Due to the recent vandalism the Howdale toilets block would be out of operation for Carnival Day including unfortunately an electrical power supply.

Borough Cllr Mrs Mellish reported she was in dialogue regarding the unsatisfactory state of grass cutting throughout the town and seeking assurances over adverse implications for the 2015 Downham In Bloom application, this included the current condition of the Amiens Project landscape at Cannon Square.

In response to a councillor's query as to The Willows Nature Reserve she reminded members that this remained work in progress.

Finally in the interests of clarity and to draw a distinction between Town Council and Borough Council representation, Mrs Mellish explained she would only be taking Old Town Ward matters back to the BCKLWN.

2888. To receive report on the Twinning Club

Cllr Ross advised members on the success of the 'Allo Allo' themed coffee morning held on Friday 8th May (VE Day). Future events included the Annual General Meeting to be held on 22nd May and the French Café Day to be held on 24th May. She reminded members of the annual Jazz picnic to be held on 21st June.

2889. To receive report on the Jubilee Community Centre

Cllr Pyatt reminded members of a recent spate of damage and advised that the possibility of upgrading the CCTV system was being investigated.

The appointed architects (Chaplin Farrant) for the re-development had produced a series of sketch drawings which were currently being reviewed by the JCC Management Committee.

He outlined the composition of the centre with the Town Council being the Sole Corporate Trustee but delegating the day to day running of the centre to the JCC Management Committee and advised a new committee would need to be formed at the July meeting of the Sole Corporate Trustee.

2890. To receive report on Town events

The Deputy Mayor Cllr Daymond advised members of:

i) Past Events

Successful events commemorating Chinese New Year with Dragon dancing on the Town Square, the St George's Day festivities, and the popular VE Day celebrations including the Hall of Stalls and excellent evening dance.

Forthcoming events included the Summer Craft Fair to be held on 4th July and the Water Festival on 9th August. He would welcome any assistance with decorating the Town Council float entered in the Festival Parade.
