**2260. To approve the minutes**

Cllr Reed commented that he felt the Mayor's address at the meeting of Tuesday 11<sup>th</sup> September 2012 was out of order, and that the Mayor should consider his position. He wished to propose a vote of censure and no confidence in the Mayor. He called for a named vote.

At this point the Deputy Mayor, Cllr Sharman took over as Chairman of the meeting.

Cllr Starling commented that the Mayor had been under extreme pressure with the emails being circulated and that he had a duty of care to try and sort the situation.

Cllr Ford commented on the email that Cllr Reed had sent to all members and Borough Councillors, he said it was divisive, taking the middle ground would be better for the Council, Cllrs Mrs Judge and Groom echoed his comments.

Mrs Mellish reminded members that her complaint to the auditors was in her name and not a matter for the Borough Council.

### County Councillor

County Councillor, Mrs S Hutson had produced a report which she read through. (Appendix 1).

Cllr Mrs Sharp congratulated the County Council that concession holders can now use the 9.05am bus to King's Lynn. However the stop in the Hollies is now only for dropping off and this makes the stop area in Bridge Street very busy. County Cllr Mrs Hutson was not aware of this situation. She reported that the Norfolk Green bus company were promised a stop in Bridge Street during regeneration. County Cllr Mrs Hutson advised the Council to deal with Norfolk Green direct.

### Borough Councillor Reports

A M Lovett, no report

Mrs K A Mellish reported that the taxi rank is not obligatory. The Church Road land sale will be decided by the end of the month.

Cllr Doyle voiced the opinion that the taxi rank had been forced on the town and that it should be located near to Tesco's if anywhere, Cllr Stacey endorsed this view.

Cllr Starling asked if there was any news from the open sessions about waste recycling, there had been no feedback as yet. Cllr Fox noted that there was a report on this subject in today's Lynn News.

Cllr Mrs Sharp asked if the Council's views with regard to the Church Road land sale will be taken into consideration. Mrs Mellish replied that Councillors could attend and comment at the Cabinet Meeting.

### Public Participation

Mrs R Bodle congratulated so many members of the public for attending the meeting, she said there was a good level of interest in Town matters. She had sent a letter to all Councillors offering her help for three months with no financial charge to the Council. (Appendix 2).

Mr Simon Prior asked if there was a strategy for the Town, he was especially concerned about the centre of Town and problems facing businesses.

Cllr Starreveld made him aware of the Downham by Design statement and that the production of a Neighbourhood plan was being considered

Cllr Groom reported that she had been part of the Regeneration Partnership for over ten years and that to provide answers for Town Problems would need a partnership, 'Let's Talk' is the latest idea but there is little support, only four people showed an interest after the latest meeting.

Ms Jane Harper asked if a 'Town Team' could be generated from this evening's meeting, the Mayor replied that this was not possible but could be born out of the Community Development Committee meetings.

Cllr Mrs Sharp voiced the opinion that a lot of young people are taking part in Town Matters.

Ms Jane Harper commented that the Town was decreasing business wise and that the chamber of Trade had suffered a large drop in membership.

Mr Phil Peads asked if the Council wanted to lead the Town forwards with a leadership role.

Cllr Starling commented that the Community Development Committee was the forum to lead things forward; ideas can be voiced at meetings.

Cllr Doyle reported that the Council keeps in contact with the schools, he read a report on how he perceived the town was progressing. (Appendix 3).

Mr Simon Prior was keen to look to the future, not the past; he asked where was the organising body for the Town's future. Cllr Groom replied that he should attend a Community Development Committee Meeting

Mrs R Bodle said that there were not now enough groups allied to the Community Development committee and that she felt that a Neighbourhood Plan was a must, but meetings had not yet taken place.

Cllr Reed voiced concern about the empty shops in Town and hoped that landlords could be persuaded to reduce rents to fill properties.

Cllr Ford commented that there was obviously a lot of interest in this subject, it was important to publicise which local Councils had responsibility in certain areas.

Cllr Doyle reminded the public that this Council receives no income from national or local Government or any business initiatives..

Ms Jane Harper commented that rents are not the issue, but footfall in Town.

The Mayor, Cllr Pegg, resumed the meeting.

#### **2261. To receive Correspondence**

A list of correspondence had been circulated (Appendix 4).

Cllr Groom noted that local footpaths were very important and that the Town Council should be involved in maintaining them.

County Councillor Mrs Hutson reminded members that the County Council had been subject to financial reductions and that footpaths could be maintained with the assistance of the public.

Cllr Stacey reported that at a recent Councillor's Surgery many members of the public had commented on the poor state of some footpaths and hedges. He thought that if the public were to be enlisted to assist then this should be publicised.

#### **2262. To receive Councillors' Questions**

Q. Cllr Starreveld reported that following an Local Development Framework meeting, it was confirmed that some 390 new homes would be constructed in Downham Market in the near future. The Borough Council are concerned over what effect this may have on the Town. 106 monies would be available and could Councillors give thought to where they think this funding could go.

Q. Cllr Sharp asked if the unused shop next to 'Feet First' in the High Street could have its mail removed from the floor.

Q. Cllr Reed reported that he had attended the recent meeting about the future of Denver Windmill. The site was now to be offered for sale and a scheme was mooted to sell shares to the public for £10 each to raise the necessary finance.

Q. Cllr Fox reminded members that their registers of interest were now published on the Town Council website. Could members check their photographs on the website and submit more recent ones if they think it necessary.
